Ineke Dezentjé Hamming - Bluemink read Law at Erasmus University Rotterdam and obtained a degree in Business Administration.

She served as Managing Director of the Rotterdam Port Promotion Council (RPPC) from 1993 to 2003. The RPPC manages the strategic marketing and communication activities of the Dutch port and maritime

industry. In this capacity she led several trade missions in various parts of the world to promote the Dutch port sector. Before that she worked as a PR Executive at the container handling company ECT in Rotterdam for 11 years, after having held a position as Head of PR & Advertising at Van Leeuwen Buizen Groep in Zwijndrecht.

In 2003 Mrs Dezentjé Hamming-Bluemink made a career switch to politics and became an MP for the People's Party for Freedom and Democracy (Volkspartij voor Vrijheid en Democratie – VVD). Initially, she was responsible for the Education & Youth Services and Finance & Economics portfolios. Towards the end of her term of office she was appointed chair of the Permanent Committee on Finance and consequently also became responsible for the State Pension & Retirements portfolio.

On 14 November 2011 Mrs Dezentjé Hamming-Bluemink was appointed President of the Dutch employers' organisation FME at the general meeting.

In September 2014 Ineke Dezentjé Hamming-Bluemink was appointed President of the European Tech & Industry Employers' organisation Ceemet, representing 200,000 companies. At the end of her term in 2016 she was elected as Ceemet's Vice President, a position she was unanimously re-elected into in 2018.


Mrs Dezentjé Hamming-Bluemink is also member of the Executive Board of the employers' organisation VNONCW.

In January 2016 she was appointed Member of the Supervisory Board of the Royal Dutch Touring Club ANWB.

Since 2017 Mrs Dezentjé Hamming-Bluemink is a member of the Cybersecurity Council and since 2018 among the 20 members of the European Commission's High Level Industrial Roundtable «Industry 2030».
