2. QUALITY JOBS ROADMAP

• The national level

IER experts should refer to any new legislation or policy initiative connected to quality jobs and/or to discussions with your trade unions on the topic within the framework of collective bargaining.

• The EU level

The Commission is set to present at the end of 2025 a Quality Jobs Roadmap. This strategy will be prepared together with the social partners under the umbrella of the Pact for Social Dialogue.

This Roadmap is a flagship initiative of the Commission that aims to promote quality jobs in the EU. It will take the form of a Communication. However, it would most probably contain some binding initiatives connected to the world of work. According to the Commission the roadmap will cover areas stretching from working conditions (including H&S, AI at the workplace), wages, skills & job transition, social protection, and career development.

Against this background in April 2025, the Commission launched a series of consultation rounds of the social partners in order to gather their input regarding the upcoming Roadmap. As part of them, Ceemet was actively involved in the structured consultation with Vice-President for Social Rights and Skills, Quality Jobs and Preparedness Roxana Mînzatu, as well as in the social partners' hearing of 8th May 2025.

Moreover, Ceemet will submit its written response to the consultation before 1st July 2025.

a. EU social dialogue

The meeting should also be the opportunity for IER experts to exchange views as regards Ceemet mid and long term strategy vis à vis industriAll Europe, in particular in a context where trade unions are sharpening their positions.

c. Ceemet & EU funded projects connected to social dialogue

Ceemet is involved as beneficiary or associated partner in a series of EU funded projects connected to social dialogue. Most of these projects involve employer and trade union organisations of central and eastern Europe and are dealing with challenging topics impacting the world of work including AI in the workplace, skills development, industrial and green transition in the MET industries etc.
