#### Education and Training Work-Programme 2025-2026

- Addressing the green and digital transition of the mobility-transport-automotive ecosystem by developing a comprehensive and sustainable skills and training strategy that addresses the current and future needs of the workforce (TRIREME-EU funded project):
  - Analyse the social aspects of the transformation of the automotive-mobility ecosystem,
  - Collect, share and analyse good examples of national, regional, local, and company initiatives and social partners'

  - Compile and analyse "less successful" practices in order to identify what has not worked
